We have had a few college recruiters coming in to present to the students recently. As opposed to just setting up a table in the lobby, more colleges have been sending instructors to visit the classes here to help spark more interest in the individual programs.

There is a big focus on apprenticeships right now. Penn College has a Youth Apprenticeship program that we are planning to get more involved with in the future.
