# Facilities/Operations/Safety Committee:

We had our first emergency drills this week. We are talking to East Lycoming about acquiring the app that they use for the drills. It would be very beneficial as it allows the teachers/staff to communicate during the drill or a real event.

Our safety committee is certified, which means we are eligible to receive a five percent discount on our insurance.

# Curriculum/Programs/Enrollment:

We billed at 299 this year; the flex enrollment was up slightly this year.

Mr. Butler is working on getting a Medical Office program started next year. He collected labor data from the Central PA Workforce Development Board and will be having an Occupation Advisory Committee meeting next month to see if it is plausible. After that, we will work on doing a student interest survey with 8<sup>th</sup> and 9<sup>th</sup> grade students.

We will begin the recruiting process soon. Mr. Butler and Liz Ann will start visiting the sending schools in October. After all of those presentations, the ninth graders will have the opportunity to participate in a visitation day here at Lyco.

# **Instruction/Professional Development:**

Our new computer instructor, Reed Kimble is doing an excellent job and the students seem to be responding well to him.

Bill Way, the construction instructor is in his second year, and doing well. He will be doing his student teaching this semester. His Penn State instructor is happy with his progress thus far.

There was a discussion about the instructors taking classes at Luzerne County Community College as opposed to Penn State. The tuition is cheaper at Luzerne, and therefore we are trying to come up with an agreement to pass some savings on to the teachers as well.

# **Communications/ Public Relations:**

The East Lycoming Recreation Authority had a banquet at Lyco last night. It went quite well; there were about fifty people in attendance.

Commonwealth Media Services was here yesterday to do a promotional video on Career and Technical Education for PDE. They toured the school and took pictures and videos in the shops. Pictures and/or videos should be on social media in the near future. The media team were very impressed with our school and stated that we had set the bar very high for the other schools that would be visiting.
